#### **PUBLIC WORKS**

1. Manuel Brother's Park Electrical Project Update

Robin Lucero stated Barry's Electric is almost completed with electrical work. The city partnered with Black Hills Energy, who donated the wire from the transformer to the meter and provided the labor and Barry will be completing the wiring. The asphalt and the curb and gutter will be completed next, and they will be finished.

2. Plow Purchase

Robin Lucero stated the plow the city has at this time is broken and after exploring several options, the best option is to purchase a new plow in the amount of \$11,433.10 The plow was not budgeted, however the funds are available in the machinery and equipment line item from the street budget so they would like permission to purchase this plow.

3. Street Sweeper Discussion

Robin Lucero stated the street department has been looking for a street sweeper for quite a while now and they have found one in North Dakota that has low miles and is smaller to fit our streets. The company is willing to deliver it and let us demo the street sweeper and make sure this is what we would like to do before signing the purchase agreement. M/Klein, S/Carr- Carried to allow the city to request a demo from the company with no cost or commitment to the city to make sure the equipment is thoroughly tested out and working properly.

4. Main Street Library Parking Signs Discussion

Robin Lucero stated this winter they would like to remove the barriers at the crosswalk by the library and place signs to make plowing more efficient and safe.
